Isidora Jarić is a Full Professor at the Department of Sociology, Faculty of Philosophy, University of Belgrade, with over two decades of academic and research experience in the fields of education, gender equality, and public health policy. Her work is particularly focused on researching and improving the position of minority, marginalized, and vulnerable social groups.

As a consultant and researcher, she has participated in numerous projects supported by both domestic and international donors (European Commission, SIDA, Swiss Development Agency, Embassy of Norway, among others), collaborating with academic, non-governmental, and governmental institutions.

Her professional expertise combines theoretically grounded analysis with practical application in the development and evaluation of public policies, particularly in the sectors of education, public health, human rights, and gender equality.
