Introduction

Approaching three decades of teaching at the Department of History, I have extensive experience in making lectures and education a highly dynamic process, aligned with lifelong learning objectives. Students' evaluations have consistently confirmed the quality of my teaching, with average scores around 4.5 (out of 5.0) for both for Introduction to Historical Studies (2006-10) and Historical geography (2006-present), which are core courses for first-year students, as well as for elective courses Territorial development and Settlements in the medieval Bosnia. As Collingwood observed – All history is the history of thought, meaning that all of the past is the present-day historians rethinking the past, and since all history takes place in a geographical setting – all history is historical geography.

After completing my magisterium and PhD in the regional historical geography of medieval and early modern Bosnia, I broadened my research interests to the preindustrial environmental history of the Western Balkans and Southeast Europe. That was the main subject of my third book and several peer reviewed articles and chapters in edited volumes on climate history, the role of alcohol and plants in food history, landscapes, and ecocritical theory.

Recently, I started new courses for senior years of BA program: Introduction to environmental history 1, and for MA students, Introduction to environmental history 2. My current work is dedicated to the historical and cultural analysis of cartography and cultural anthropology, offering fresh perspective on the very construction of historical knowledge as socially situated and gendered. Through this work, I have developed deep self-reflection as a female historian, historical geographer, and an environmental historian within local and global scholarly community, as well as in relation to humanity in general.
